THE UNIVERSITIES ACT, No. 16 OF 1978

ORDINANCE made by the University Grants Commission under Section 24A read with section 18 of the Universities Act, No. 16 of 1978.

Ordinance

1. This Ordinance shall be cited as the National Centre for Advanced Studies in Humanities and Social Sciences (Amendment) Ordinance, No. 3 of 2008.

2. The National Centre for Advanced Studies in Humanities and Social Sciences Ordinance, 2005 published in *Gazette Extraordinary* No. 1415/17 of October 19, 2005 is hereby amended as follows :-

(1) in paragraph 6 of that Ordinance, by the repeal of item (c) thereof and the substitution therefor of the following item :-

“(c) Boards of Study.”;

(2) in paragraph 7 of that Ordinance, by the repeal of sub-paragraphs (2) and (3) thereof, and the substitution therefor of the following :

“(2) (a) The Council of Regents shall consist of :-

(i) the Minister in charge of the subject of Higher Education, who shall be the Chairman ;

(ii) the Chairman of the Commission ;

- (iii) the Chairman of the Council of Management ;
 - (iv) the six (06) Deans of the Faculties relevant to disciplines of Humanities and Social Sciences, nominated by the respective Standing Committees ; and
 - (v) four (04) members appointed by the Commission from amongst persons who have achieved eminence in related or relevant fields, in the opinion of the Commission.
- (b) The Chairman shall preside at all meetings of the Council of Regents. Provided that in the absence of the Chairman, the Chairman of the Commission shall preside at all meetings of the Council. In the absence of the Chairman and the Chairman of the Commission from any meeting of the Council of Regents, the members present shall elect one from among those present to act as Chairman for the meeting.
- (3) The President shall be the Patron of the Centre and the Council of Regents and the Council shall when necessary to do so meet with the President.” ;
- (3) in paragraph 11 of that Ordinance :-
- (1) by the repeal of sub-paragraphs (3) and (4) thereof, and the substitution therefor of the following :-
“(3) The Council of Management shall consist of.—
 - (i) the Director, who shall be the Chairman ;
 - (ii) the six (06) Deans of the Faculties relevant to disciplines of Humanities and Social Sciences, nominated by the respective Standing Committees ;
 - (iii) four (04) members appointed by the Commission from amongst persons who have achieved eminence in related or relevant fields, in the opinion of the Commission.” ;
 - (2) in sub-paragraph (6) thereof, by the substitution for the words “one-fourth” of the words “one-third” ;
 - (4) by the repeal of paragraph 13 and the substitution therefor of the following :-
“13. The Council of Regents may on the advise of the Council of Management, from time to time appoint academic and other bodies as are deemed necessary for the purpose of advising the Council of Regents on academic and other related matters.”.
